Components of the Declaration Form

Important points to note:

- ◇ Once a document was submitted to the Integrity Commission in relation to an Asset and there was no changes to that asset during the declaration period, then you don't have to resubmit that document in other submission.
- ◇ In the event of a death of a Specified Officer, a Death Certificate, is required to remove the name from the Commission's Database, the Copy of the Death Certificate can be submitted by anyone.

Understanding the Sections or Components of a Declaration Form

Annual Period: the period required for a Specified Person in Public Life to submit a declaration of Assets & Liabilities. E.g. July 01, 2024 to June 30, 2025.

Name and Address of the Specified Person in Public Life

Name and Address for Spouse and Children. These must be stated together with the relationship to the Specified Person in Public Life. E.g.

Vihaan Anthony (Husband)

Viron Anthony (Son)

Simran Anthony (Daughter)

Income, Assets and Liabilities

Income: (Name and Address of Organization) together with the amounts of monies received for the annual period in relation to same e.g. July 01, 2024 to June 30, 2025. Documents required might be any of the following that is APPLICABLE to your source of income listed:

Assets held by a Specified Person in Public Life, his or her Spouse and Children (below 18 years old) at the end of a Declaration Period.

The Specified Person in Public Life to provide a clear description of Assets and the value of same stated at the end of the declaration period. These Assets and Supporting Documents stated categorically are:

Property – Transport, Certificate of Title or Lease Agreement, and Estimated Cost of Property. If you have a current valuation you can submit same however, it is NOT compulsory.

Cash / Bank Account – Indicate clearly account name and balances in and out of the Country at the end of the Declaration Period e.g., as at June 30, 2025

Life Insurance Policies – Copy of Insurance Policy

Shares – Share Certificate, Letter of Valuation

Directorship and Partnership – Articles of Incorporation, Business Registration, Partnership Agreement, Change of Directors Notice.

Motor Vehicle – Motor Vehicle Registration Certificate and estimated cost or purchase cost (sale receipt) if any for Vehicle in use and estimated cost of Vehicle no longer in use.

Boat – Registration Certificate and estimated cost

Government Bonds – Security Bond

Gifts - Deed of Gift, Affidavit of Gift, Transfer of Gift

Any Other Assets – Supporting Document to Support the Asset

Income, Assets and Liabilities

Liabilities of a Specified Person in Public Life, his or her Spouse and Children (below 18 years old) at the end of a declaration period. A liability is something a person or company owes, usually a sum of money. It must state clearly the name of the liability, the institution attaching the liability, the balance of money owed and the person claiming the liability e.g. Specified Person in Public Life or Spouse. These are:

Mortgage –indicate clearly institution name and balance at the end of the declaration period . e.g. as at June 30, 2025

Supporting Documents (Not Compulsory): Mortgage Deed, Mortgage Statement or any other Document.

Loan (Motor Vehicle Loan/ Personal) –indicate clearly institution name and balance at the end of the declaration period . e.g. as at June 30, 2025

Supporting Documents: Loan Agreement, Loan Statement (Not Compulsory)

Judgement Debts – Supporting Documents: Judgement Debt Letter/ Court Document

Others - Any other document that support a liability listed under this section

Date & Signature - the first date & signature is when the specified person in public life prepared the Declaration Form

The full name of the Specified Person in Public Life

The relevant date could be any of the following, date of employment, last date worked or last date of a declaration period.

Final Signature of Specified Person in Public Life. This signature is an attestation by the Specified Person in Public Life confirming the information provided is true and correct as at June 30, on the declaration form for the declaration period.
